My primary role as a Specialty Program Psychologist was management of the Reintegration Housing Unit (RHU) Program at the Federal Correctional Complex (FCC) in Oakdale, LA. The RHU is a residential treatment program which employs principles of a modified therapeutic community (MTC) to meet the special needs/issues of a high security correctional population and encourages a healthy and crime-free approach to life. Responsibilities included overseeing daily operations of the program; supervising program treatment specialists; conducting individual diagnostic interviews; developing and implementing individualized treatment plans for mentally ill participants; monitoring inmate progression through the program and implementing behavior modification plans when needed; developing and implementing enhanced programming and re-entry initiatives to improve program outcomes; conducting crisis intervention; confrontation avoidance; suicide risk assessments; risk assessments for sexual violence and victimization; conducting both individual and group therapy focusing on anger management; dialectical behavior therapy; basic cognitive skills; criminal thinking; and social skills training.

Other duties included staff training on Managing Inmate Sexual Behavior, Crisis Negotiation and BOP Hostage Policy, Care of Mentally Ill Inmates to include suicidal inmates and inmate victims/perpetrators of sexual violence; Educating staff on effective communication and the influence of perception and personality in the workplace; Dispute Resolution Specialist (staff mediation); CPR Instructor; START staff sponsor (inmates speaking with at-risk youth in the community); Employee Assistance Program (EAP) counselor; Mental Health Expert for FCC Pollock/Oakdale Crisis Negotiation Team.

My primary role as an intern at the Federal Medical Center (FMC) in Devens, MA is to deliver psychological services to inmates of varying security levels who struggle with a wide range of psychological problems. Responsibilities included administration and interpretation of psychological tests; diagnostic evaluations; risk assessments; crisis intervention; sexual assault and suicide prevention, confrontation avoidance, grief counseling, adjustment to incarceration issues; management and treatment of behaviorally disordered inmates; individual and group therapy. In addition to learning the general duties required of a staff psychologist, I have had the opportunity to receive specialized training in four different areas including: Training Director: Dr. Diana Hamilton

Severe and Persistent Mental Illness (20 hours per week for four months)

Complete clinical intake interviews with newly admitted inmates; develop diagnostic formulations and treatment plans; conduct individual; management of a caseload of 15-20 severely mentally ill

inmates (e.g., assess current levels of functioning, risk of harm to self or others, make appropriate treatment and supervision recommendations, monitor the inmate's adherence to institution rules, create discharge summaries and recommendations for step-down treatment). Group therapy including skill acquisition with lower functioning inmates and trauma survivors process; received specialized training in psychotic disorders and neurocognitive assessment tools.

Drug Abuse Programming (20 hours per week for four months)

Conduct individual diagnostic interviews for residential substance abuse program referrals; group substance abuse education aimed at helping inmates identify risks of substance use, factors that perpetuate substance use, and tools for relapse prevention; conduct Non-Residential Drug Abuse Program treatment groups aimed at helping inmates identify and correct irrational thoughts that support their substance use, understand triggers for substance use, develop alternative coping tools, gain an understanding of high risk situations, and develop plans for relapse prevention.

Sex Offender Treatment Program (SOTP) (40 hours per week for four months)

Conduct psychosexual evaluations utilizing objective measures (e.g., static 99, penile plethysmograph, personality and cognitive assessment) and structured clinical interview to develop diagnosis, treatment plan, and assessment of risk for each participant in the residential treatment program; conduct individual and group therapy (e.g. victim impact, intimacy skills, basic cognitive skills, emotional regulation, relapse prevention); participated as an interdisciplinary team member in treatment and management of inmate sexual misconduct.

Forensic Evaluation (40 hours per week for four months)

Administer and interpret psychological tests (e.g. assessments of personality, intelligence, malingering, risk assessments) for court-ordered assessments; conducted evaluations of competency and criminal responsibility; conducted collateral interviews with relevant sources; extensive record reviews; generated forensic reports for the courts; conducted competency restoration group for inmates found incompetent to stand trial; observed court proceedings and expert witness testimony; received specialized training in personality and cognitive assessment; competency to stand trial; criminal responsibility; relevant case law; and ethics in forensic practice.

Offenders who were assigned to participate in the Mental Health Treatment court work with a Treatment Team which includes representatives from the Office of the District Attorney, Office of the Public Defender, the Probation Department and appropriate treatment providers. As part of this Treatment Team, my duties included: conducting psychological assessments; administering and interpreting personality/cognitive testing; making

recommendations to the court regarding the appropriate diagnosis and treatment of participants; and providing group counseling to treatment court participants.
